

TERMS OF REFERENCE FOR SERVICE PROVIDER TO SUPPORT MARKET ACCESS ACTIVITIES FINAL FOLLOW-UP FOR THE WOMEN IN TRADE FOR INCLUSIVE AND SUSTAINABLE GROWTH (WIT) PERU – AGRIFOOD SECTOR/BUYERS' MISSION

Preamble:

TFO Canada (Trade Facilitation Office Canada), a non-government non-profit organization, is implementing the project **Women in Trade for Sustainable and Inclusive Growth,** funded by Global Affairs Canada, and is seeking a service provider preferably located in **Peru** to implement the final follow-up activity to Small and Medium Enterprises (SMEs) that participated in the market access component of the project.

Background:

TFO Canada is implementing the project Women in Trade for Inclusive and Sustainable Growth (WIT) in 23 developing countries in Africa, Asia, the Middle East, Latin America, and the Caribbean, a project funded by Global Affairs Canada. Working in partnership with Trade Support Institutions (TSIs), the project will address the main constraints faced by women exporters such as their lack of knowledge, skills, resources, and network to access global trade as well as their low involvement as members and leaders of trade support institutions.

The project is also addressing challenges faced by women exporters who are under-represented and under-served by public and private TSIs, and increasing the number of women from developing countries involved in international trade as exporters and also the share of exports generated by women-led Small and Medium Enterprises (SMEs).

The project is focused on the following sectors: artisan and home decor products, agro-food, Services (animation, software development, video games), Apparel, and Textiles, which present opportunities for employment creation particularly favorable to women. To increase access to Canadian and other international markets for women-led SMEs in these sectors, the project improves the ability to identify and respond to Canadian and other export market demands by organizing Trade missions (exporter missions and buyer missions).

In partnership with **PromPeru** in **Peru**, TFO Canada organized different Trade Missions for Selected Small and Medium Enterprises (SMEs) from 2022 to 2024. The purpose of these trade missions was to support selected SMEs to establish commercial linkages with prospective Canadian and International buyers and to have optimal access to the Canadian and other International markets.

TFO Canada is conducting a final follow-up activity to support the consolidation of potential commercial relationships established during the trade missions. To this end, TFO Canada is hiring a Service Provider to assist the TFO Canada team with the follow-up activity.

Assignment:

Based on the above background, TFO Canada is looking for a Service Provider that execute the final follow-up activities with the **14 SMEs** that participated in the **Buyers' Mission to Peru, 2024.**

- Experience working with project beneficiaries through a participatory approach
- Ability to communicate in the following languages: English and Spanish.
- Experience working with surveys, collecting and summarizing data, and using trackers
- Excellent computer application skills, particularly Microsoft Word, and Excel, as well as some experience working with database applications

- Letter of interest outlining the experience of the service provider in similar assignments.
- Technical and financial proposal
- Two samples of recent similar work done following up with project beneficiaries
